## Library Resolution Update:

On September 5, the PCRP resolution regarding the Pickens County Library Director and Board was presented to the regular meeting of the Pickens County Council. There were two speakers who were concerned about what they perceived as possible "book banning," but the PCRP resolution was well-received by the audience. It was stressed that it was the responsibility of the board to exercise oversight of the library (and the director) and the council was asked to empower the board to do their job: requiring a vote to approve the director's plans would cement the role of the board.

Stephanie Howard, the director, has emailed at least one of our members saying that there is no requirement for the board to vote; she does not feel she needs any approval before scheduling events.

That is why Stephanie scheduled Jason Reynolds, the author of Stamped, to attend a Hampton Branch book signing shortly after the school board removed his book from the school district libraries. And that is why there have been some very questionable movies shown at the library. However (and this is important!), the SC Code of Laws states that it's the board members who are responsible to "employ a chief librarian.... acquire books and materials....and take any actions deemed necessary and proper by the board to establish, equip, operate, and maintain an effective library system...." In other words, the board's responsibility is oversight – the director does not have free rein. What are the next steps for PCRP?

"We the People" need to actively recruit new members for the library board – members who will stand firm and not be tempted to give in or to rubber stamp the

director's plans without careful consideration. There are three seats open NOW: one in the Clemson area (Councilwoman Linville Claiborne's district), one in the Six Mile area (Councilman Chris Lollis' district) and one in the Liberty area (Councilman Roy Kostner's district). If you are interested in one of these roles, please fill out the application on the county web site and make sure that you contact your councilperson personally. We must have people on the board who will exercise their lawful authority. 2. PCRP members need to attend and observe the library board meetings. There may/may not be an opportunity to speak, but it's imperative that we are aware of what's discussed, and we need to support our own Danny Parton, Executive Committeeman from East Pickens and a member of the board, as he encourages careful consideration and discussions in the meetings.
